- the sum of \$ 619,000 ✓ to be levied as a special tax for purposes of the Local Governmental and Governmental Employees Tort Immunity Act (745 ICLS 10/9-107), and
- the sum of \$ 120,000 ✓ to be levied as a special tax for Social Security and Medicare insurance purposes (40 ILCS 5/21-110 and 5/21-110.1), and
- the sum of \$ 44,000 ✓ to be levied as a special tax for financial audit purposes (50 ILCS 310/9), and
- the sum of \$ 45,000 ✓ to be levied as a special tax for protection, health, and safety purposes (110 ILCS 805/3-20 3 01), and
- the sum of \$ 0 to be levied as a special tax for (specify) _____ purposes, on the taxable property of our community college district for the year 20__

When any community college district is authorized to issue bonds, the community college board shall file in the office of the county clerk in which any part of the community college district is situated a certified copy of the resolution providing for their issuance and levying a tax to pay them. The county clerk shall each year during the life of a bond issue extend the tax for bonds and interest set forth in the certified copy of the resolution. Therefore, to avoid a possible duplication of tax levies, the community college board should not include in its annual tax levy a levy for bonds and interest.

This certificate of tax levy shall be filed with the county clerk of each county in which any part of the community college district is located on or before the last Tuesday in December

RESOLUTION APPROVING TAX LEVY

WHEREAS, the Board of Trustees of Community College District No. 507 has *done all things* required by all applicable statutes; and

WHEREAS, the Board has determined that it is necessary for the District to raise the necessary funds by the levying of taxes:

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Community College District No. 507, Counties of Vermilion, Edgar, Iroquois, Champaign and Ford, State of Illinois, that the following sums be levied for the fiscal year beginning July 1, 2007:

- ✓ 1. The sum of \$3,494,100 be, and is hereby levied as a tax for educational purposes;
- ✓ 2. The sum of \$702,800 be, and is hereby levied as a tax for operations and maintenance purposes;
- ✓ 3. The sum of \$55,000 be, and is hereby levied as a special tax for Worker's Compensation insurance purposes;
- ✓ 4. The sum of \$564,000 be, and is hereby levied as a special tax for tort liability purposes;
- ✓ 5. The sum of \$44,000 be, and is hereby levied as a special tax for auditing services purposes;
6. The sum of \$120,000 be, and is hereby levied as a special tax for Medicare and FICA insurance purposes;
- ✓ 7. The sum of \$45,000 be, and is hereby levied as a special tax for Protection, Health, Safety purposes;
8. The sum of \$576,473 be, and is hereby levied as a special tax for Building Bond repayment purposes.
9. The Sum of \$41,935 be, and is hereby levied as a special tax for Technology Funding Bond repayment purposes.

BE IT FURTHER RESOLVED that the Vice Chairperson and Secretary of said Board of Trustees be, and they are hereby instructed to prepare a Certificate of Tax Levy covering said amounts and purposes and that the Tax Levy is filed with the County Clerk of the respective counties, in accordance with statutes made and provided.

BE IT FURTHER RESOLVED that this resolution shall be in full force and effect from and after its passage.
