WHEREAS, the Board of Trustees of the Village of Fisher, County of Champaign and State of Illinois, did pass the Annual Budget and Appropriation Ordinance entitled "Village of Fisher Annual Budget and Appropriation Ordinance 2007-2008" and said Ordinance was duly published as required by law to be filed with the Clerk of Champaign County, Illinois; and

WHEREAS, the Board of Trustees anticipates receipts from the real estate Levy of \$52,408.00 with the balance of its funds to be received from sales tax, state income tax, federal and other sources.

THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Fisher, Champaign County, Illinois:

SECTION 1:

That there be and is hereby levied upon all the taxable property within the corporate limits of said Village of Fisher, as the same is assessed and equalized for the current fiscal year, the total sum Fifty Two Thousand, Four Hundred Eight Dollars (\$52,408.00) being the total of appropriations heretofore legally made which are to be collected from the tax levy of the current fiscal year for the Village of Fisher for all Corporate Fund, General Fund, and Municipal Tort Immunity Fund for the specific purposes mentioned in said Appropriation Ordinance and in respective sums as follows:


SECTION 3:

The said several sums of money are hereby appropriated from monies received and to be received by the VILLAGE OF FISHER, from all sources, and nothing set forth herein shall prohibit transfers from one Village fund to another provided such monies are disbursed in compliance with law, this ordinance and subsequent tax levies. *In the event that any portion of this ordinance is deemed invalid, the balance of said ordinance shall be given full force and effect to the extent allowed by law.* To the extent any of the levied sums exceeds the legal limit of such levy, then the amount levied shall be the maximum allowed by such limit.


SECTION 4:


