**ORDINANCE No. 5**

An ordinance levying taxes for all town purposes for NEWCOMB Township,  
Champaign County, Illinois, for the tax year 2007, collectable in 2008.

BE IT ORDAINED by the Board of Trustees of Newcomb Township,  
Champaign County, Illinois, as follows

SECTION 1 That the sum of one hundred nine thousand \_\_\_\_\_

property subject to taxation within the Township as that property is assessed and equalized, in order to

BE IT ORDAINED by the Board of Trustees of Newcomb Township,
