ORDINANCE NO. _____

An ordinance levying taxes for all town purposes for Ogden Township ,
Champaign County, Illinois for the tax year 2007, collectable in 2008.

BE IT ORDAINED by the Board of Trustees of Ogden Township, Champaign
County, Illinois as follows:

SECTION 1: That the sum of---ONE HUNDRED FIFTEEN THOUSAND
NINE HUNDRED TWENTY-FOUR----Dollars (\$115,924.00) are hereby levied upon all
property subject to taxation within the Township as that property is assessed and
equalized, in order to meet and defray all the necessary expenses and liabilities of the
