RESOLUTION

WHEREAS, the BOARD OF TRUSTEES OF COMMUNITY COLLEGE DISTRICT NO. 505 (PARKLAND COLLEGE) COUNTIES OF CHAMPAIGN, COLES, DEWITT, DOUGLAS, EDGAR, FORD, IROQUOIS, LIVINGSTON, MCLEAN, MOULTRIE, PIATT, VERMILION AND STATE OF ILLINOIS caused to be prepared in tentative form a Budget, and the Secretary of this Board has made the same conveniently available to public inspection for at least thirty (30) days prior to final action thereof; and

WHEREAS, a public hearing was held as to such Budget on the 19th day of September, 2007, notice of said hearing was given at least thirty (30) days prior thereto as required by law, and all other legal requirements have been complied with; and

WHEREAS, said Budget was duly and properly passed by said Board of Trustees on September 19, 2007; and

WHEREAS, this Board of Trustees now desires to adopt and pass said 2007 tax levy.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF COMMUNITY COLLEGE DISTRICT NO. 505 (PARKLAND COLLEGE) COUNTIES OF CHAMPAIGN, COLES, DEWITT, DOUGLAS, EDGAR, FORD, IROQUOIS, LIVINGSTON, MCLEAN, MOULTRIE, PIATT, VERMILION AND STATE OF ILLINOIS, as follows:

SECTION 1

That the Certificate of Tax Levy for this district for the fiscal year 2007-2008 is as follows and shall be adopted as the Certificate of Tax Levy for this college for said fiscal year:

We hereby certify that we require the sum of Eleven Million Five Hundred and Sixty Five Thousand and no/100 Dollars (\$11,565,000) to be levied as a special tax for educational purposes; and the sum of Four Million Four Hundred Fifty Thousand and no/100 Dollars (\$4,450,000) to be levied as a special tax for operations and maintenance of facilities purposes; and the sum of Two Million Two Hundred and Twenty Five Thousand and no/100 Dollars (\$2,225,000) to be levied as a special tax for protection, health and safety purposes; and the sum of One Million Four Hundred

Eighty Five Thousand and no/100 Dollars (\$1,485,000) to be levied as a special tax for tort liability purposes; and the sum of Two Hundred Forty Five Thousand and no/100 Dollars (\$245,000) to be levied as a special tax for Workers Compensation Insurance; and the sum of Four Hundred Five Thousand and no/100 Dollars (\$405,000) to be levied as a special tax for Medicare Insurance; and the sum of Nineteen Thousand and no/100 Dollars (\$19,000) to be levied as a special tax for Unemployment Insurance; and the sum of Three Hundred Twenty Six Thousand and no/100 Dollars (\$326,000) to be levied as a special tax for property insurance; and the sum of Eighty One Thousand and no/100 Dollars (\$81,000) to be levied as a special tax for financial audit purposes, all on the equalized assessed value of the taxable property of our District for the year 2007.

- II. The corporate and special purpose property taxes extended for 2006 were Nineteen Million Eighty Six Thousand Six Hundred and Ninety Six Dollars (\$19,086,696).  
The proposed corporate and special purpose property taxes to be levied for 2007 are Twenty Million Eight Hundred One Thousand Dollars (\$20,801,000). This represents an eight and ninety eight hundreds percent (8.98%) increase over the previous year.
- III. The property taxes extended for debt service and public building commission leases for 2006 were Zero Dollars (\$0.00).  
The estimated property taxes to be levied for debt service and public building commission leases for 2007 are Zero Dollars (\$0.00). This represents a Zero percent (0.00%) increase over the previous year.
