

SECTION 1

That there is hereby appropriated for the revenue year beginning May 1, 2008 the sum of \$11,482.00 upon all property subject to taxation within the Sidney Fire Protection District in Champaign County, Illinois, to pay the costs of purchasing of insurance to protect against any loss or liability which may be incurred by the said Sidney Fire Protection District all as provided by the "Local Governmental and Governmental Employees Tort Immunity Act," 745 ILCS 10/1-101 through 10/10-101.

Liability insurance premiums to be contracted for \$11,482.00 ✓

That said sum so levied shall be in addition to all other taxes authorized by law to be levied and collected by the Sidney Fire Protection District and shall not be included in any limits or rate contained in "An Act in Relation to Fire Protection Districts" or any other law, but shall be excluded therefrom and be in addition thereto and in excess thereof. Said tax shall be in addition to the taxes levied for general corporate purposes under "An Act in Relation to Fire Protection Districts" and other taxes authorized by law.

SECTION 2:

That there is hereby appropriated for the purposes of the Sidney Fire Protection District for the fiscal year beginning May 1, 2008, the sum of \$393.00 to pay the expenses of the audit and investigation of the accounts of the Sidney Fire Protection District as provided by "An Act in Relation to Fire Protection Districts" being Chapter 70 ILCS 705/6.1.

Expenses of audit and investigation of Accounts \$393.00 ✓

That said sum so levied shall be in addition to all other taxes authorized by law to be levied and collected by the Sidney Fire Protection District and shall not be included in any limits or rate contained in "An Act in Relation to Fire Protection Districts" or any other law, but shall be excluded therefrom and be in addition thereto and in excess thereof. Said tax shall be in addition to the taxes levied for general corporate purposes under "An Act in Relation to Fire Protection Districts" and other taxes authorized by law.

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of the Sidney Fire Protection District, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.
