BE IT ORDAINED by the Trustees of St. Joseph-Stanton Fire Protection District in Champaign County, Illinois:

SECTION 1: That there is hereby levied for the fiscal year the objects and purposes of the St. Joseph-Stanton Fire Protection District in Champaign County, Illinois, the following amounts as herein itemized and set forth for general fund:

For Utilities -----	8,000.00
For Firefighter Training -----	3,000.00
For Building Maintenance -----	2,500.00
For Fire Fighting Equipment -----	6,500.00

For Payroll -----	28,000.00
For Apparatus -----	7,500.00
For Contingent expenses -----	842.42

SECTION 2: That there is hereby levied for the fiscal year the objects and purposes of the St. Joseph - Stanton Fire Protection District in Champaign County, Illinois, the following amounts as herein itemized and set forth for emergency and rescue fund:

SECTION 3: That there is hereby levied for the fiscal year the objects and purposes of the St. Joseph - Stanton Fire Protection District in Champaign County, Illinois, the following amounts as herein itemized and set forth for Liability Insurance fund:

SECTION 4: That there is hereby levied for the fiscal year the objects and purposes of the St. Joseph - Stanton Fire Protection District in Champaign County, Illinois, the following amounts as herein itemized and set forth for audit fund:

**TOTAL ESTIMATED AMOUNT REQUIRED - \$207,942.42**



ADOPTED by the Trustees of the St. Joseph - Stanton Fire Protection District on NOVEMBER 21, 2007.

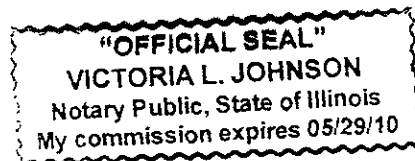
